



Youth Power Wheels Race Registration Form

SATURDAY, MAY 18, 2024, AT 11:30AM IN DOWNTOWN BEDFORD

REGISTRATION DEADLINE IS MAY 10, 2024.

Entry fee: \$5 (Non-refundable)

RULES

1. ELIGIBILITY

- Participants must be between the ages of 3 and 17 years.
- Each participant must have a registered power wheel for the race.
- Each driver must provide his/her own Power Wheels vehicle.



2. Safety Gear

- All participants must wear appropriate safety gear, including a helmet, and closed-toe shoes.
- Costumes and decorations should not obstruct the participant's vision or impede their ability to operate the power wheel safely.

3. Power Wheel Requirements

- Only electric power vehicles with 4 wheels are allowed. No gas-powered vehicles are permitted.
- Power wheels must be in good working condition and pass a safety inspection before the race.
- Modified power wheels must adhere to safety standards and specifications outlined by the event organizers. Modified vehicles may be put into their own division.

4. Course Regulations and Race Conduct

- Participants must always follow the designated racecourse.
- Participants must obey all traffic rules and signals on the course.
- No intentional interference with other participants is allowed.
- Only race officials are permitted on the racecourse.
- If a driver exhibits poor sportsmanship, dangerous driving behavior, or any other risk, Event Organizers/Race Officials reserve the right to disqualify the driver(s).

5. Start and Finish:

- Participants must start and finish the race in their designated lane.
- The race will begin with a designated starting signal, and participants must stop at the designated finish line. The vehicle to cross the finish line first will determine the winner.
- Arrive between 11-11:15am at the Coverlet Museum on race day to check in. The race will begin at 11:30am.

6. Emergency Situations

- In case of an emergency, participants must follow the instructions of race officials.
- Emergency medical personnel will be on-site, and participants should seek immediate assistance for any injuries.

7. Waiver and Release:

- All participants must sign a **Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement.**
