

Wing Vendor Requirements

ALL VENDORS MUST

1. Sell wings as the focus of your booth, however additional food items may be sold along with soft drinks/water.
2. Provide a Certificate of Liability Insurance with application.
3. Purchase your own food items and handle collecting payment from customers.
4. Supply your own tent w/tie downs (10'x10' is recommended), table, chairs, cooking apparatus, etc.
5. Be responsible for your own garbage clean-up at the end of the event.
6. *Set your own prices and post your own sign in a visible area of your booth.*
7. Provide your own generator, propane, if cooking on-site. *(Electricity is available for a fee.)*

NOTE TO ALL VENDORS

- *DBI will sell adult beverages.*
- *Wheels & Wings will be held RAIN or SHINE!*
- *All spaces will be assigned on a first-come, first-served basis. Vendors with specific needs (electricity, generators, additional spaces, etc. will be placed accordingly).*
- *Changes can be made at the discretion of Downtown Bedford, Inc., or the Borough of Bedford.*

2024 Wing Contest Rules

1. Entry fee of \$50 and contest entry must be completed before the deadline of May 1, 2024. Must provide a valid email address.
2. Contest entries will be judged by a panel of three (3).
3. Judging will be based on flavor, doneness, texture, and appearance.
4. All wings must be properly cooked per Pennsylvania health department. Undercooked wings will result in disqualification.
5. All contestants must display a current food handler's certificate.
6. All cooking utensils are the responsibility of contestants.
7. All wings, sauces, rubs, and any ingredients are the responsibility of contestants.
8. Wings need to be ready to eat at 12pm on the day of the contest.
9. Only "bone in" wings will be judged. They can be either drums or flats.
10. All decisions will be final.
11. A pre-contest email will be sent the week before the competition to finalize details.
12. Winners will be announced at the closing of the competition.
